

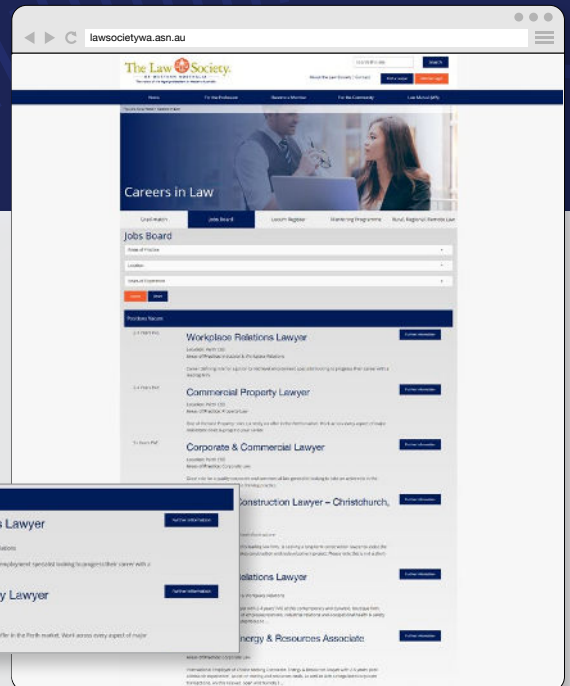
LAW SOCIETY JOBS BOARD
