Cluedunnit Kids

My name is Cab Allerial, and I live at 13 Halfpipe Road in Frontside. My house is next door to the new housing development. Honestly, I wish they would hurry up and build something there.

On 15 December at 3.30pm I was collecting honey from my urban hive around the back of my house.

When I am at home, I usually leave the garage door open to let the air flow through. I don't have much in the garage, but I do store an extra fridge there.

I always keep the back fridge fully stocked with soft drinks for when visitors or my grandkids come.

It was a very hot day, and I was busy tending to the bees. I remember I heard some kids on skateboards out the front.

Anyway, since it was hot I went to grab a drink and was very surprised to find that my soft drink multi pack had been taken. I had only brought it the day before.

It was then I noticed some writing on the fridge door which wasn't there before. I think the writing was what they call graffiti.

Then I started to connect the dots and realised I had been robbed! Some scallywag had stolen my softies so, I called the Police.

I am a sergeant at Frontside Police Station. On 15 December 2025, a call was received from Mr Cab Allerial who lives at 13 Halfpipe Road, Frontside.

Constable Beni Hana and I attended 13 Halfpipe Road at approximately 4.30pm on the same date.

Mr Allerial reported that on the morning of 15 December 2025, he had purchased a box of 24 cans of soft drinks and left them in the fridge in his garage. At around 3.45pm, when he had gone to grab a cool drink from the back fridge, all of the cans of soft drink were gone.

Mr Allerial added that there was some red writing on the door of his fridge in the garage. He didn't know what it was, but he said it had not been there before. I inspected the writing and confirmed it was a graffiti tag reading I-SK8.

After speaking to Mr Allerial, Constable Hana and I reviewed the scene and confirmed with Mr Allerial that the garage door was up from approximately 11am to 3.50pm on 15 December. He also confirmed that there was no barrier to anyone wanting to enter and exit the garage.

I noticed that the house at number 10 Halfpipe Road had a CCTV camera, so I went to speak to the owner, Ms Varial Smith. Ms Smith confirmed she had seen three young people with skateboards skating and making lots of noise around the time of the incident.

She confirmed that her CCTV camera worked and covered the immediate front of her property but not the properties across the road. I asked to see the CCTV footage from the around the time she had seen the young people.

After reviewing the footage on Ms Smith's CCTV system, Constable Hana and I went to the Alley-Oop skatepark. At the skatepark, I saw three individuals who matched the appearance of the three skaters in Ms Smith's CCTV footage.

Constable Hana and I approached and told them we were investigating an offence of stealing from 13 Halfpipe Road. After speaking to the three skaters, I determined to take them to the Station for questioning.

Each of the suspects gave their name, age and address as follows:

- Ollie North, 16 years old, 44 Boardslide Way, Frontside
- Casper Flip, 15 years old, 360 Shuvit Crescent, Frontside
- Indy Grab, 15 years old, 70 Bullflip Rd, Frontside

I told them they did not have to say anything or answer any questions. I also told them anything they told me would be recorded and could be used in evidence against them in court.

As they were all under the age of 18, I told them a parent or guardian would need to be present while they were interviewed.

Ollie North and Casper Flip replied, “Yes, okay whatever.” Indy Grab said, “We ain’t done nothing, bro”.

I repeated the caution to her and asked if she understood. She confirmed that she did understand.

At the Station, each of the suspects were individually interviewed with a lawyer and a responsible adult present. Each gave their name, date of birth and address again. They made no other comments, as is their right, during the interview.

At the Station after obtaining a forensic procedure order, I photographed each of the suspects. **Those photographs are included in this Brief of Evidence; SC01** Ollie North, **SC02** Casper Flip, **SC03** Indy Grab

I arranged for Constable Hana to get fingerprints and hand swabs from each suspect and take photos of the contents of their bags, the suspect's shoes and each of their skateboards.

The phones of each suspect were seized; a Data Access Order was not necessary as they all gave me the passcode.

On 15 December 2025, Sergeant Shelby Court and I attended a property at 13 Halfpipe Road, Frontside. The owner, Mr Cab Allerial, told us that a whole carton of soft drinks had been stolen from a fridge located in the garage of the house. He also noted that there was red writing on the door of the fridge which was not there earlier.

Sergeant Court and I inspected the fridge in the garage and confirmed with Mr Allerial that the garage door had been open from 11am till 3.50pm and there was no barrier to anyone entering.

I identified a red graffiti tag which read I-SK8 on the fridge. I took a photo of the tag and labelled it **BH01 (included in this Brief of Evidence)** and a swab of the tag and labelled it **BH02**. I took a photo of the inside of the fridge and labelled it **BH03 (included in this Brief of Evidence)**.

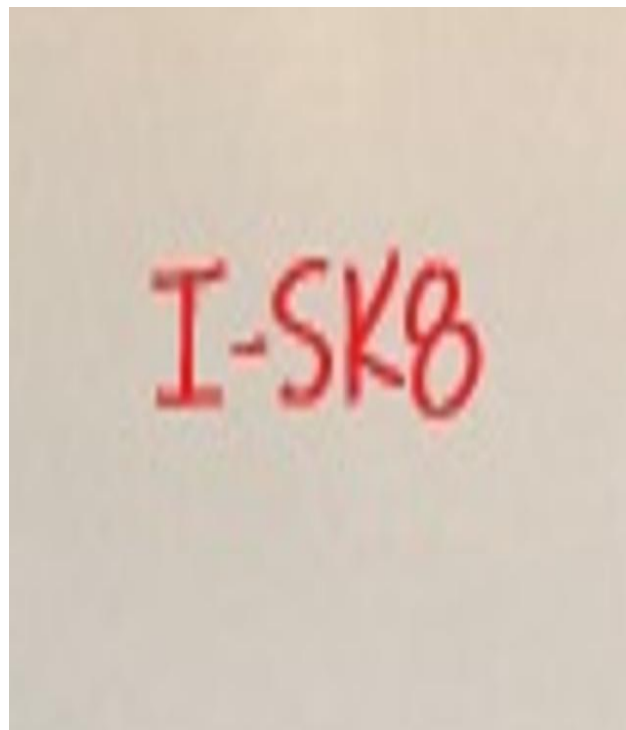

There was a fresh footprint on the garage floor, I took a photo of the footprint and labelled it **BH04**.

Sergeant Court returned from a neighbouring property after viewing CCTV footage and asked me to attend the Alley-Oop skatepark with him.

At the skatepark, Sergeant Court identified three skaters who matched the appearance of the individuals he had seen in the CCTV footage. We approached and told them we were investigating an offence of stealing from 13 Halfpipe Road.

After speaking to the three individuals, Sergeant Court determined to take them to the Station for questioning.

At the Station I took fingerprints and hand swabs from each suspect. I put on new gloves each time and took swabs from the hands of each youth. I labelled them **BH05** (Ollie North), **BH06** (Casper Flip) and **BH07** (Indy Grab) and placed them into sealed evidence bags.

To collect the suspects' fingerprints, I put on new gloves each time and took prints from the hands of each youth. I labelled them **BH08** (Ollie North), **BH09** (Casper Flip) and **BH10** (Indy Grab) and placed them into sealed evidence bags.

I also took photographs of the hands of each suspect and labelled them **BH11** (Ollie North), **BH12** (Casper Flip) and **BH13** (Indy Grab).

I photographed the contents of the suspects' bags. I put on fresh gloves for each bag and labelled the items in the bags as follows, placing them into individual labelled and sealed evidence bags.

- **BH14** Ollie North's bag - **BH14a** Thin nib red marker, **BH14b** Open bag of Jaffas, **BH14c** Five empty cans of soft drink, **BH14d** Two unopened cans of soft drink, **BH14e** Ollie North's mobile phone.
- **BH15** Casper Flip's bag – **BH15a** Thick nib magenta marker, **BH15b** Three empty cans of soft drink, **BH15c** Four unopened cans of soft drink, **BH15e** Casper Flips' mobile phone.
- **BH16** Indy Grab's bag - **BH16a** Thick nib red marker, **BH16b** Open bag of Red Rippers, **BH16c** Five empty cans of soft drink, **BH16d** Five unopened cans of soft drink, **BH16e** Indy Grab's mobile phone.

Next, I photographed the suspect's skateboards and labelled them **BH17** (Ollie North), **BH18** (Casper Flip) and **BH19** (Indy Grab).

I also took photographs of the suspects shoes and labelled them **BH20** (Ollie North), **BH21** (Casper Flip) and **BH22** (Indy Grab).

On the 16 December at 10.30am I returned to 13 Halfpipe Road to check the fridge door for latent fingerprints. I was able to dust the handle of the fridge and lift viable prints from the surface. I have labelled the lifted prints **BH23**.

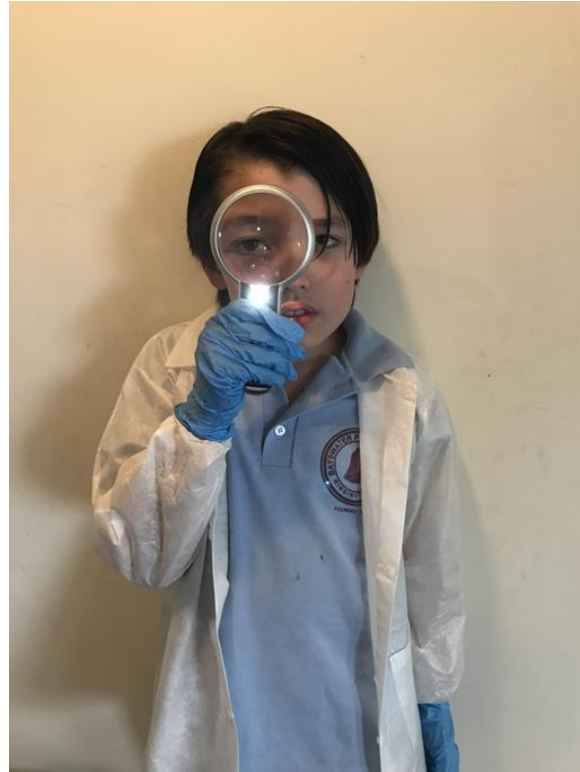

My name is Dr Dee Enay. I am a chemical analyst at the State Analytical Laboratory. I have a Doctorate in Chemistry and a post-graduate degree in Forensic Science.

On 17 December 2025, I took possession of a number of evidence bags related to a matter at 13 Halfpipe Road, Frontside, on 15 December 2025.

Sergeant Shelby Court requested that I forensically examine the following items, all of which were received in sealed evidence bags, and I prepared reports on my findings.

DE01	BH05 BH06 BH07	Swab analysis report of the hand swabs of the three suspects
DE02	BH23a – Print One BH23b – Print Two BH23c – Print Three	Fingerprint analysis report of the lifted latent fingerprints
DE03	BH02	Chemical analysis of the swab taken from the graffiti on the fridge
DE04	BH14a, BH15a, BH16a	Chemical analysis of the chemical components of each marker pen

Note for Investigators

If a forensic exhibit number lists multiple item/s being analysed (like the three suspects' fingerprints) these are considered bundled exhibits and investigators can ask for a report on those items by asking only one question.

The majority, but maybe not all, of Dr Dee Enay's Forensic Exhibits are noted in his statement.

The Frontside Police need your assistance to identify the prime suspect in this matter who will be charged with the following:

- Unlawfully on Premises (Trespass) (s70A(2));
- Stealing (s378); and
- Unlawful Damage (graffiti) (s445).

The Frontside Police also need your assistance to identify two suspects in this matter who will be charged with the following:

- Possessing stolen or unlawfully obtained property (s417).

As the suspects are aged between 10 and 17, if these matters proceed to court, they would be heard in the Children's Court of Western Australia.





Cluedunnit Kids: Question Rules

1. **Maximum of 6 questions per school** to get more evidence to identify the prime suspect and the other two suspects.
2. Schools running an in-school competition have to **share the 6 questions** across the in-school teams.
3. Cluedunnit **questions must be directed to someone.**
4. Cluedunnit **questions must be specific in what they are asking.**
5. Cluedunnit **questions can only request one thing; not multiple things.** *The exception is forensic evidence such as cross referencing a DNA analysis of the three suspects with an item at the crime scene.*
6. Cluedunnit **questions must come from the students.**

Aim to have asked all six of your questions by the end of Term 1 at the latest.
